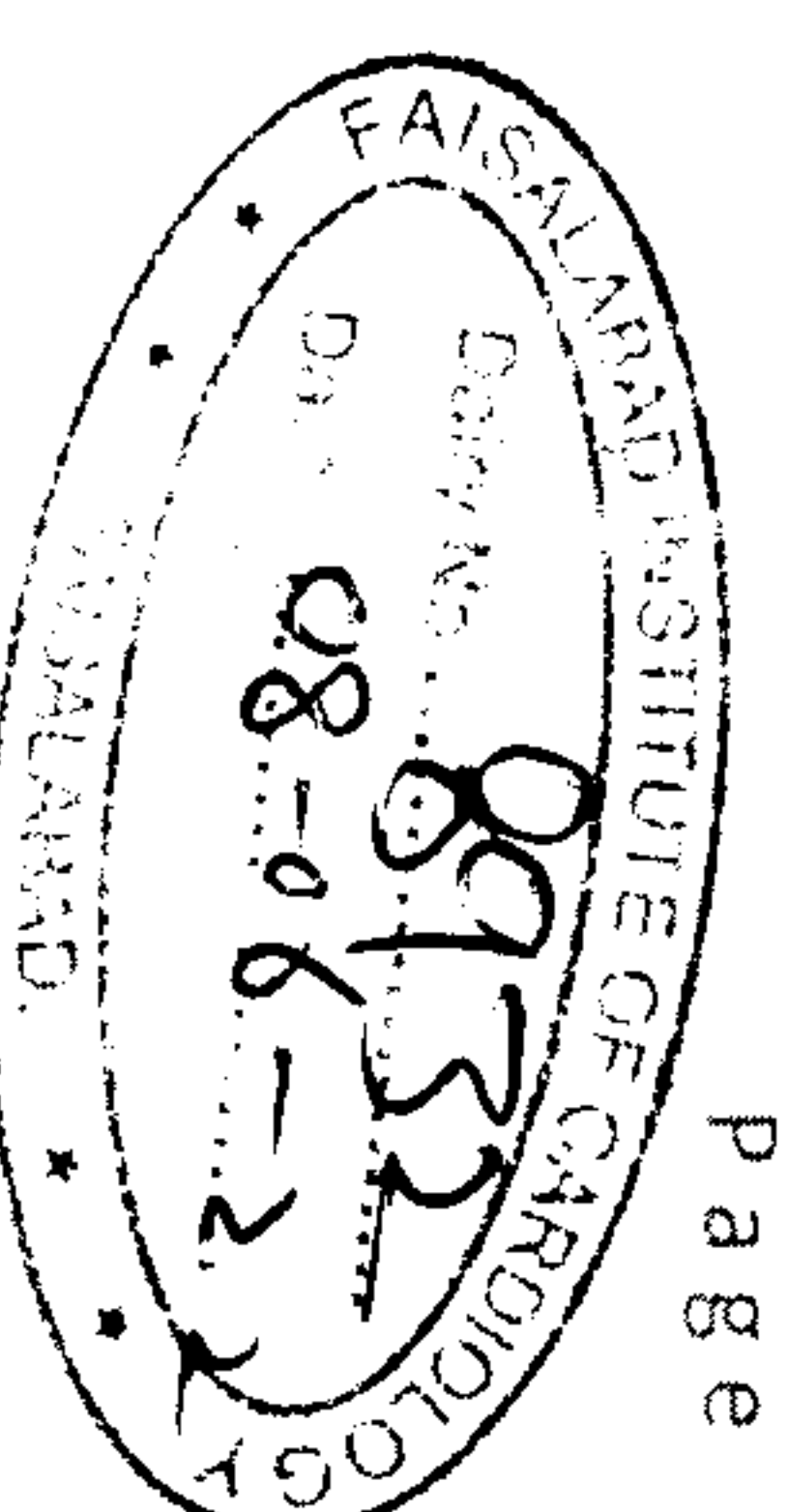


**MINUTES OF GRIEVANCE COMMITTEE MEETING




